**BEFORE ME**, the undersigned Notary Public, duly commissioned and qualified in and for the Parish and State hereinabove set forth, and in the presence of the undersigned competent witnesses, on this 10<sup>th</sup> day of June, 2022, personally came and appeared:

**Beau Chene Homeowners Association, Inc.**, a Louisiana non-profit corporation organized and existing under the laws of the State of Louisiana, domiciled and doing business in the Parish of St. Tammany, represented herein by Ernst den Hartigh, its duly authorized President, pursuant to the Resolution of the Board of Directors, an original of which is attached hereto and made a part hereof, its mailing address being 105 Beau Chene Blvd., Suite 102, Mandeville, Louisiana, 70471 (hereinafter sometimes referred to as the "BCHOA").

**WITNESSETH**

**WHEREAS**, on or about October 31, 1978, Beau Chene, Inc. executed that certain document entitled "Fourth Act of Modification and Third Supplementary Act of Dedication of Servitudes, Privileges and Restrictions by Beau Chene, Inc. – Adoption of Servitudes, Privileges and Restrictions by Marina Beau Chene, Inc." which was filed in the records of the Clerk of Court for the Parish of St. Tammany, State of Louisiana, at Conveyance Book 901, Folio 344 (hereinafter the "Original Restrictions"); and

**WHEREAS**, the Original Restrictions govern Beau Chene Subdivision, located in Mandeville, Louisiana (the "Subdivision"); and

**WHEREAS**, the BCHOA was created pursuant to the Original Restrictions and is the governing body of the Subdivision; and

**WHEREAS**, pursuant to Article XI, Section 1 of the Original Restrictions, in order to amend or modify the Original Restrictions, the owners of a majority of the lots in the Subdivision must sign an instrument agreeing to such amendment or modification; and

**WHEREAS**, the Subdivision contains 1551 lots and 781 owners, representing in excess of a majority of the lots in the Subdivision, have executed an Amendment Approval Form, agreeing to the amendment and modification set forth below, an index of which is attached hereto and made a part hereof, the originals of which are on file with the BCHOA (the "Approval Instruments").

**NOW, THEREFORE**, the BCHOA does hereby attach the index of the Approval Instruments hereto and, in accordance therewith, the Original Restrictions are therefore amended and modified as follows:

**I.**  
**AMENDMENTS**

1.1 Article I, Section 1 of the Original Restrictions shall be amended so as to add a new subsection (k), as follows:

(k) "Short-Term Rental" shall mean and refer to the lease or rental of all or any portion of any Dwelling or Multi-Family Structure, for dwelling, lodging or sleeping purposes, to one or more party(ies) with the duration of occupancy being less than (60) sixty consecutive days, whether such Dwelling or Multi-Family Structure is listed for rental on any online rental agency website or otherwise.

1.2 Article VIII, Section 1 of the Original Restrictions shall be amended so as to add a new subsection (y), as follows:

(y) No Short-Term Rental of any Dwelling or Multi-Family Structure within Beau Chene, Marina Beau Chene, or any property within any of the individual condominium regimes located within Beau Chene or Marina Beau Chene and subject to the Act of Dedication. Notwithstanding the foregoing, in the event of exigent circumstances or other consideration that does not conflict with the intent of maintaining owner occupancy and disallowing short term tenancy, an Owner may request a limited waiver of the foregoing restriction by submitting a written request to the Association setting forth the specific circumstances giving rise to the request, the proposed terms and conditions of the lease or rental and a copy of the proposed lease agreement. The Association, through its Environmental Control Committee may grant or deny the requested waiver, in its sole discretion.

**INDEXING INSTRUCTIONS**






**BE IT FURTHER RESOLVED** that the President is authorized and empowered to do any and all things and execute any and all documents necessary in furtherance of the foregoing.
